Evaluation of Offer

We will evaluate the technical and price information in the received bids.

After the technical evaluation, only the price offers of bids with more than 500 points will be opened and evaluated. Technical offers below 500 points will be considered as technical not acceptable The technical offer has a weighting of 70%, the price offer 30%. The following formula will be used:

 $\frac{\textit{technical evaluation of bid x 70}}{\textit{technical evaluation of best bid}} + \frac{\textit{most economical bid x 30}}{\textit{price of bid}}$

The final result is an overall ranking, headed by the most cost-effective bid. Contract negotiations will be initiated on the basis of this overall ranking.
